1. 행정구역의 변천

- 2천여년 전 장산국(또는 거칠산국)이라 칭함.
- 757년 신라 경덕왕 16년 동래군이라 칭함.
- 1021년 고려 현종 12년 동래현이 됨.
- 1393년 조선 태조 2년 동래진이 됨.
- 1547년 조선 명종 2년 동래부(도호부)로 됨.
- 1914년 동래군으로 됨(동래군, 부산부 분리).
- 1942년 부산부에 편입 - 동래출장소 설치.
- 1963년 직할시 승격(법률 제1173호)으로 구역조정(동래군 북면 6개동 편입).
북면출장소 설치 - 선동, 두구동, 노포동, 청룡동, 남산동, 구서동.
- 1975년 동래구 승격(법률 제407호), 북면출장소 폐지 - 직할동으로 편입.
- 1988. 1. 1 대통령령 제12367호(1987. 12. 31 공포)로 동래구에서 분구 금정구 설치.
(동래구 중 서1, 2, 3, 4동, 금사동, 오륜동, 부곡1, 2, 3동, 장전1, 2, 3동, 선동, 두구동, 노포동, 청룡동, 남산동, 구서1, 2동, 금성동)
- 1992. 9. 1 부산직할시 금정구조례 제273호에 의거 부곡동에서 부곡4동 분동.
- 1998. 11. 1 부산광역시 금정구조례 제504호에 의거 오륜동은 부곡3동으로 통합, 노포동은 청룡동으로 통합, 선동은 두구동과 합하여 선두구동으로 통·폐합.
- 1999. 10. 1 부산광역시 금정구조례 제544호에 의거 청룡동이 청룡노포동으로 명칭변경.
- 2004. 4. 30 대통령령 제18336호(2004. 3. 29 공포)로 동래구 명장2동 일부지역($3,250\text{m}^2$) 금정구로 편입.

1. Changes of the Administrative Areas

- Called Jang San Guk (or Gochilsan guk) about 2,000 years ago.
- Called Dongnae Gun in 757, the 16th year of King Kyongduk.
- Designated as Dongnae Hyun in 1021, the 12th year of King Hyunjong Koryo Dynasty.
- Designated as Dongnae Jin in 1393, the 2th year of King Tagjo, Chosun Dynasty.
- Designated as Dongnae Bu (DohoBu) in 1547, the 2th year of Myoungjong , Chosun.
- Designated as Dongnae Gun in 1914. (Separated as Dongnae Gun and Busan Bu)
- Included in Busan Bu in 1942. (Dongnae Agency was Established)
- Upgraded as a Direct Control City and District Arranged in 1963. (Law No. 1173)
(Including 6 Dongs in Northern Dongnae Gun)

Northern Agency was Established - Seon Dong, Dugu Dong, Nopo Dong, Cheongnyong Dong, Namsan Dong, Guseo Dong.

- Upgraded as Dongnae Gu in 1975. (Law No. 407)
Northern Agency was closed in 1975 - Included in Direct Control City.
- Geumjeong gu was Established Separately from Dongnae Gu in Jan. 1. 1988
by Presidential Order No. 12367. (Exclaimed on Dec 31, 1987)
(Seo 1, 2, 3, 4 Dong, Geumsa Dong, Oryun Dong, Bugok 1, 2, 3 Dong, Jangjeon 1, 2, 3 Dong, Seon Dong, Dugu Dong, Nopo Dong, Cheongnyong Dong, Namsan Dong, Guseo 1, 2 Dong, Geumseong Dong, among Dongnae Gu)
- Bugok - 4 Dong was Separated from Bugok 1 Dong on Sep. 1, 1992 by the regulation No. 273 of Geumjeong Gu, Busan.
- Oryun Dong was integrated to Bugok 3 Dong, Seon Dong and Dugu Dong was abolished to SeonDugu Dong, Nopo Dong was Integrated to Cheongnyong Dong on Nov. 1. 1998 by the regulation No. 504 of Geumjeong Gu, Busan.
- Cheongnyong Dong was revised to CheongnyongNopo Dong on Oct. 1. 1999 by the regulation No. 544 of Geumjeong Gu, Busan.

2. 지역 특성

○ 지역이 광활한 주거도시로 변모하는 지역

동쪽의 회동수원지와 서북쪽의 금정산 사이로 대부분의 거주지가 형성되어 구 면적이 부산광역시의 8.54%인 65.20km²로 지역이 광활하며, 부곡, 장전, 남산, 구서, 청룡지구의 대단위 아파트 단지조성 및 주택건설 등으로 쾌적한 주거도시로 변모되어 가는 지역임.

○ 사권제한 구역이 넓은 도·농 복합지역

개발제한구역이 38.68km²(구면적의 59.3%)이며 수원보호구역이 27.58km²(구면적의 42.3%)로 사권제한 지역이 넓고, 18개동 중 3개동이 농촌동으로 도·농 복합 지역으로서 행정수요가 다양하며 주민의 발전기대 욕구가 높은 지역임.

○ 육로 교통의 요충지

부산의 동북부 관문으로서 경부고속도로 도시고속도로 및 지하철호선의 기종점이자, 부산종합버스터미널이 위치하고 있는 육로교통의 요충지임.

○ 문화 및 관광의 고장

우리나라 5대 사찰중 하나인 금정산 범어사는 경내에 산재한 국가 및 지역문화재를 중심으로 천연기념물 제176호인 등나무 군이 울창한 사찰림과 어울려 수려한 경관을 이루고 있으며, 금정산성과 함께 부산의 관광지로 각광을 받고 있음.

2. Regional Specialties

- **Wide-ranged Region changing to residential city**

Hoedong water source in eastern part and Geumjeong Mountain foot in North Western part has mostly formed a residential district and reach up to 65.20Km² which is 8.54% of Busan Metropolitan City, and it is the area changing to comfortable residential city with the housing construction and making a large scale apartment complex of Bugok, Jangjeon, Namsan, Guseo and Cheongnyong district.

- **Complex of urban and rural areas with limited private-ownership**

Green belt regions and water source preserving regions cover 38.68 Km²(59.3% of Gu area) and 27.58 Km²(42.3% of Gu area), so area of limited private ownership is wide, and 3 out of 18 dongs are rural, so administrative needs are various and it is the region to which demand of development expectation of residents is high.

- **Center of Traffic Roads**

As the gate of east and north part of Busan, starting and terminal points of Seoul-Busan expressway, urban expressway, and 1st Subway Line, and it is the central point where Busan composite bus terminals are located.

- **Cultural and Tourist City**

One of the 5 greatest temples in Korea, Beomeosa has national and regional cultural properties, exclusively wisteria woods, the Natural Monument No. 176. Its beautiful scenery and thick forests are highly appreciated as a tourist attraction in Busan.
